Strengthening Families Through Prevention and Collaboration

Family Engagement: A Collaborative Process for Systems Change

This session explores the question of how to change a system designed to protect children from their families to one that supports families to keep their children safe and healthy. The session examines the question from several perspectives, including that of a mother and son with lived experience and leaders who set the tone and direction for putting families at the center of child welfare work through strategies such as family finding, father engagement, and icebreaker conversations. Finally, the session highlights the literal and spiritual interconnection of Native families and how to engage families in a trauma-informed manner.
