This resource emphasizes effective strategies in coaching to improve family engagement in child welfare practice and how it is particularly effective in building skills and mastery for family engagement.

This tool, developed for use by Leadership Academy for Middle Managers participants, can help leaders assess how well their organizations are operating in alignment with family-centered principles and practices.

Youth Engagement Resources:

In these audio stories, youth describe how their voices were heard while in foster care. Each story is anchored by a youth's perspective and is partnered with another perspective—a caseworker, leader, attorney, or peer mentor. Adolescence is a time of massive changes that shape the trajectory of adult lives. The youth explain how engagement at the practice, peer, and system levels gave them the support and empowerment they needed during this critical developmental period.
2. [Embracing a "Youth Welfare" System: A Guide to Capacity Building](#)
This guide focuses on challenges that state child welfare agencies face when working with youth. To address these challenges, the guide presents the Youth Welfare approach, which outlines how agencies can shift from a child-focused system to a youth-focused system by implementing practices that support youth and their needs. Agencies and others working with youth in care can access the complete guide or download the tools, which include a graphic and several exercises to build staff knowledge and skills in youth welfare.
